Reduce speed limit to 30mph. KCC have installed 2 white gates under their small works budget 2020. One at the bend just before entering the village close to Selling Station and one close to the junction at Monica Close and Selling Road. Traffic survey was completed during September 2021, with measures across Selling Road, close to The Sondes, with an average speed northbound of 32.9 mph and southbound 31.8 mph. As a result of advice from KCC Highways and Kent Police following the traffic survey, the Parish Council amended the request speed limit to 30mph at the 18 th November 2021 meeting. TRO for 30mph agreed with KCC. Consultation resulted in 11 comments, 9 in support, 2 negative comments. TRO agreed and expected implementation July 2023. TRO came into force on the 4th August 2023 . Latest action: 1. When the missing 30mph metal roundel will be replaced at Monica Close. Waiting to hear. 2. Why is there only one metal roundel at Crouch Lane. No room to install another post on the other side of the road. 3. Can we request road	1. Traffic survey required to establish existing speeds. Fifty percent of drains on the right-hand side of Fox Lane (from Selling Road) are blocked by silt caused by torrent of water coming from polytunnel fields. Water flow has caused 400mm of erosion to the carriageway. 80% of water filling the dip under the bridge is coming from Selling Road side, 20% is from Oversland. June 2023 site visit with Alex Brauninger. The maintenance requirements have been noted and sent to maintenance teams to action gully cleansing and clearing mud. First action is for cleansing of the existing drainage in Fox Lane which is programmed under a single day road closure on the 21 st September 2023. Actioned on 21-09-23. Followed by work at the junction of Selling Road and Fox Lane to improve the existing drainage and repair the damage to the road edges. Expected date in November 2023. And then install new drainage by way of a large soakaway in the green by Monica Close to capture the water coming from the south before it has a chance of making the turn into Fox Lane during the first quarter of 2024.	1.
