### 071.22.01 Welcome and apologies for absence

### 071.22.02 Declarations of interests and dispensations

## 071.22.03 Items to be taken in a private session

### 071.22.04 Planning Applications

**22/503126/FULL Cherry Tree Farm, Grove Road** Change of use of existing agricultural building and surrounding plot to 1 dwelling and associated alterations.

Members of the public and councillors spoke against this proposal. Cllr Bowles proposed that the parish council should object to this planning application and request a site visit should officers be mindful to approve the application, seconded by Cllr Saunders. A vote took place and it was agreed unanimously.

Resolved: An objection to the planning application will be made.

**Action:** The Clerk to summarise the objections raised and draft a response to be approved by Cllr Bowles and submitted to Swale Borough Council.

22/502692/FULL Application for minor material amendment to approved plans condition 2 to allow an increase in size and relocation of the building within the site – Land North of Perry Leigh, Grove Road.

**Action:** The Clerk to request an extension for comments to the 19<sup>th</sup> August to allow the application to be reviewed at the next Ordinary Parish Council meeting.

### 22/503058/FULL 1 Sycamore Cottages

Cllr Bowles proposed that the parish council should submit a response of 'No Objection' to this application. Seconded by Cllr Day. A vote took place 4 votes agreed with the proposal and 2 abstentions.

**Resolved:** The parish council have no objections to this planning application.

#### 071.22.05 Prep Kits

It was proposed to purchase 3 prep kits at a cost of approximately £40 for the village defibrillators by Cllr Day and seconded by Cllr Kitchen, a vote took place and it was agreed unanimously.

Resolved: Prep Kits will be purchased for all three defibrillators.
